Mechanical work shall not be started until the application for permit has been filed with Onondaga Township. All Installations shall be in conformance with the State Mechanical Code. No work shall be concealed until it has been approved by the Onondaga Township Mechanical Inspector.

The name of the Mechanical Inspector and the telephone number will be provided on the permit form. When ready for an inspection, call the inspector and provide as much advance notice as possible. The inspector will need the job location and permit number.
