

**MINUTES OF THE March 10, 2022
REGULAR BOARD MEETING**

The regular meeting of the Onondaga Township Board was called to order on March 10, 2022, at 7:00 PM. The location for this meeting was held at Onondaga Township Hall.

APPROVAL OF BILLS:

Treasurer Ammerman made a motion to approve the bills. Trustee Garner seconded. All Ayes.

TREASURER: Summary Statement of Condition was submitted. Treasurer Ammerman stated that the tire grant was approved, and more information would be coming out.

CLERK: Clerk Seavolt suggested that Supervisor Hutchison have a meeting with Daniel Plyler, regarding his monthly obligations as a Township Inspector.

SUPERVISOR: Supervisor Hutchison stated that the BOR had organizational meeting and he was very pleased with the new assessors. He mentioned the old assessing system is very behind and the 20% will be handled. He mentioned that the clock in Town Hall was fixed, and he checked on that invoice for water testing, and it is not required.

FIRE DEPARTMENT: Chief Tow submitted report. He also mentioned that he would order the flags for Cemetery and mentioned getting a credit card for the FD just as he had with the old board.

PLANNING COMMISSION: Matt Austin reported the PC has made progress on the review of Master Plan. He publicly apologized for the derogatory remark.

ZONING ENFORCMENT: Rodger Hector submitted report.

1. Lawn Mowing Bids: There were 4 bids all together. Treasurer Ammerman made a motion to hire Saratan Mow and Snow at \$19, 380 for the 2022 Lawn Mowing Season. Gardner Seconded. 4 Ayes, 1 Nay. Motion Carried for Saratan Mow and Snow.

NEW BUSINESS:

1. Planning Commission Member: Richard Hoskins to be appointed as new PC Member. Myers made motion. Garner seconded. All Ayes. Motion Carried.
2. Ingham County Round Commission: Discussion and packet given regarding the roads that can be done under the road plan.
3. ARPA: Roads are priority, it was mentioned that when the County completes road jobs they should be inspected before paid out. Chief Tow will get a cost on turn out gear.
4. Special Assessment v Mileage: The Board has decided to go for a straight mileage for the Fire Department.
5. Sloan Onondaga Dragway review of last season and pre-season discussion: Clerk Seavolt submitted a report. She mentioned that Mr. Sloan would have to provide proof of insurance and bond for the Dragstrip. Mr. Sloan was on board with everything mentioned and he will be meeting with the Zoning Enforcer, Planning Commission Chair and 2 Board Members before the 2022 season starts.
