# MINUTES OF THE October 12, 2023 REGULAR BOARD MEETING

**SUPERVISOR:** Supervisor Hutchison mentioned Blight and Health Department on Baseline Rd. He mentioned the yellow building and received 2 bids for furnaces:

- 1. Absolute: Outside unit with AC=\$7700
- 2. Hometown Heating: Outside unit with AC=\$6900
- 3. Clerk Seavolt made motion to have Hometown Heating. Treasurer Ammerman seconded. All Ayes. An \$850 deposit will be needed to get started but will get back.

He mentioned that the Nicole is still interested in renting the yellow building. Mr. Komyathy would like to see the yellow building become a food pantry, discussion was had, and Dennis discussed the research he had done. Clerk Seavolt mentioned that the Board needs to contact Nicole and verify what her plans are first before moving forward with food pantry.

- 4. Looking for Board approval to have vendor print and mail 9-day early postcards for 3000 it would cost around \$1000 and potentially absent voter applications \$1350, (fully reimbursable). Treasurer Ammerman made motion to approve the vendor printing. Trustee Myers seconded. All Ayes.
- 5. New Drop Box: storage/surveillance Chief Tow mentioned that it could be stored at the Fire Barn.
