**SUPERVISOR:** Supervisor Hutchison said that FOOT went well this year \$1000 was donated to Park, \$1000 for Outreach, \$1000 to Food Pantry. He also mentioned that he has 3 blight issues happening now. He mentioned that the yellow building still needs a furnace, and the foundation needs siding.
